

CLIMATE SMART AGRICULTURE DIALOGUE A GREAT SUCCESS





he DARDLEA MEC Ms Nompumelelo Hlophe has committed that the information gathered during the Provincial Climate Smart Agriculture Dialogue would be used as a basis to develop action plans, policies and programmes of the Department, and hoping that all participants would be ambassadors for the ideas advocated in the Climate Smart Agriculture approaches. This, during her closing remarks at a two-day Provincial Climate Smart Agriculture Dialogue, which was attended by farmers, Organised Agriculture, Experts, Researchers and other key stakeholders. The session was held on November 5-6 at the Capital Mbombela.

MEC Hlophe noted that in the overall discussions, issues of funding, collaboration, awareness, capacity and training as well as research came out strongly as important enablers. Therefore, the department commits to prioritize disaster risk reduction measures such as the effective implementation of mitigation and adaptation strategies, focusing on important elements such as issuing of weather warnings, awareness creation and response capabilities to ensure pro-activeness to reduce risks and prevent disaster.

The Dialogue aimed to share experiences in agricultural resilience and adaptation to natural disasters, and to further discuss the Climate Smart Agriculture Strategic Framework. Mpumalanga was the third province to host the Dialogue, after Limpopo and the Free State.


CONTINUED RESEARCH ON NEMATODES IS NEEDED



Valuable discussions and collaborative relations among stakeholders is one of the solution to resolving challenges posed by Nematodes, which can impact negatively to yields. This was evident when representatives from the DARDLEA, Agricultural Research Council, the University of Mpumalanga, North West University and Belgium's Ghent University gathered at the Nooitgedacht Research Center in Ermelo on 27th November 2024, who all emphasized the importance of continued in-depth research on Nematodes, to help farmers enhance sustainable farming practices.

Nematodes are microscopic, worm-like organisms that are common soil pests affecting plants. The DARDLEA's Nematology Coordinator Ms. Mpumi Nobela made a presentation detailing the current progress on the Nematology project, focusing on achievements thus far, and outlined the future. A Provincial Nematology team was also introduced to the group of stakeholders in attendance.

he DARDLEA's Environmental Affairs Unit visited the Sasol site as part of their bi-annual Stakeholder Engagement which marked a significant step toward fostering environmental sustainability and social impact through innovative partnerships. The fruitful engagement between the two, held on 8th November 2024 at Sasol in Secunda, focused on how Sasol's resources and expertise in waste management could enhance the Department's projects, benefiting local communities and protecting the shared environment.



As part of the discussions, DARDLEA and Sasol looked at Community empowerment, Environmental responsibility, and innovative waste management. The Department presented its efforts in sustainability and exploring ways to partner with SASOL on climate-smart solutions and waste reduction. The department was taken through valuable insights into Sasol's commitment to re-using ash, fine coal as well as advanced water conservation practices. Sasol has also shared their impactful projects that focus on youth and women's empowerment, health initiatives and skills development, aimed at uplifting communities.

MASIBEKELA LIVESTOC K FARMERS ATTEND FARMERS DAY

Livestock farmers in Masibekela and surroundings in Nkomazi braved the heat and showed up in numbers for a Livestock Farmers Information Day held at the local community hall on 11 December 2024, hosted by our Farmer Support Unit and the Agricultural Research Council (ARC) at the local community hall.

The interactive farmers day focused on the importance of Livestock Branding, poisonous plants on livestock, Clinical Diseases, Bull selection guidelines, Cattle Synchronization and Artificial Insemination, Animal Generic Service and Lumpy Skin Disease Control.



WASTE COLLECTORS EMPOWERED THROUGH WORKSHOPS



orkshops on waste management and recycling aimed at empowering Waste Collectors continued in Mashishing, in the Thaba Chweu Local Municipality on 9 December 2024, a collaborative effort between Zonda Insila Programme under Pollution and Waste, the national Department of Forestry, Fisheries and the Environment, PETCO and the local municipality.

Recyclers from as far as Simile in Sabie and Graskop also attended the session, during which they received more information on Waste Management, Regulations, Waste Collection and Recyclable Material, motivation, including an opportunity to network and share experiences. Similar workshops continue taking place throughout the province.

with great aplomb. They shared fond memories about their on-the-field experience, skills gained, and challenges they overcame. The department extended its appreciation for their contribution and tireless efforts pushing for animal health.



DARDLEA AND CGA HOST A CITRUS FARMERS DAY



itrus farmers from the Lowveld gathered at our offices in Mkhuhlu near Hazyview for a Citrus Growers Information Day, during which a wide range of topics were deliberated upon. The DARDLEA collaborated with the Citrus Growers Association in hosting this session on November 29th, that featured valuable information on Financial Management and funding opportunities from SEDA, Land-Bank and Standard Bank. This included tips on how best the farmers can grow their farming businesses.

Presenters from the Citrus Growers Association spoke on Black Spot, its management and Pests control. Other presenters were from the ARC, Netafirm Company, and the Citrus Academy Training, who presented on compliance matters such as the need for farmers to get South Africa Good Agricultural Practices (SA-GAP) accreditation.







WORKING TOOLS FOR HLALANIKAHLE RECYCLING



lalanikahle Recycle & Scrap from Ezinambeni in Emalahleni have received 15 trolleys, 20 colour-coded bins, a fenced office-converted container and 30 sets of PPEs for its members, from a Corporate Social Investment responsibility programme by AECI. The donation was officially handed over on 23rd October 2024, thanks to a collaboration between PETCO, DARDLEA, national Department of Forestry, Fisheries and the Environment, Nkangala District Municipality and Emalahleni Local Municipality.

The AECI, a global mining organization that already operates in 5 sites in Emalahleni alone, believes that this kind of support is a sustainable model for the beneficiaries, while ensuring a cleaner and healthier environment, as enshrined in the Constitution of the Republic, Act 108 of 1996.

Hlalanikahle – started by 5 members 4 years ago – has since grown to 15 youthful and energetic members who collect recyclables, sort and prepare it for the market. The group believes that waste must not end at landfill sites, but must be recycled, resold and reused. The members believe the sky is their limit, because the donated equipment will benefit their operations. They say in Trash, they see Treasure. In Waste, they see Wealth.
