# **BID NOTICE AND INVITATION TO BID**

CALL TO ENTERPRISES INTERESTED TO BECOME MARKET AGENTS TO SUBMIT BID PROPOSALS TO RECEIVE TRAINING TO BECOME ACCREDITED AGENTS TO TRADE IN FRESH PRODUCE IN THE NEWLY DEVELOPED MPUMALANGA INTERNATIONAL FOODMARKET.

#### **BACKGROUND**

The Mpumalanga Provincial Government has established Mpumalanga International FoodMarket (MIF) to perform various activities including provision of market access to local producers and ensuring that products are made available to consumers at a convenient place and time, in the required quantities and quality, and at fair prices.

While set to be South Africa's first large scale FoodMarket, the MIF will adopt the Commission Agent Trade Model used by national fresh produce markets. Thus, sales at MIF will occur through intermediaries, known as fresh produce Market Agents who will play a crucial role in selling fresh produce on behalf of farmers and serve as aggregators and intermediaries of fresh produce.

Accordingly, a call is hereby made to enterprises interested to become Market Agents, to submit Bid Proposals to receive training to become accredited agents to trade in fresh produce in the newly developed Mpumalanga International FoodMarket as part of efforts to drive the sector towards diversity, inclusivity and equitability.
